THE FRANCIS HENRY FAMILY OF POLAND, OHIO

Early American records show various spellings of the name Henry, Hendry, Hendre and Hennery. There were twenty or thirty different families that settled along our eastern seaboard in the early 1700's. It is generally assumed that the vast majority were Scottca-Irish and basically Presbyterian in their religion. It is difficult to trace them to their homes abroad. Probably most were originally Scots. To properly understand the reason for much of the early migration to America, I will attempt a brief summary of conditions leading up to it.

A SHORT HISTORY OF PRESBYTERIANISM IN SCOTLAND AND AN EXPLANATION OF THE NAME SECRETS CORNERS

In 1560, under the leadership of John Knox, The Scottish Parliament passed the acts abolishing the papal jurisdiction of the Roman Catholic Church. This was the start of the Reformation.

The Church of Scotland then became Presbyterian which stood for freedom and the rights of the middle and lower classes against the crown and the aristocracy.

For the next century they were to be torn by strife, not over matters of faith, but over practical questions of the church government and of the relation between church and state.

They were opposed and persecuted by the three Stuart Kings, who insisted that the Episcopal Church, with a Bishop as the highest authority, supplant, or at least have jurisdiction over the Presbyterian Church of Scotland.

This conflict was settled in favor of the Presbyterians by the National Covenant of 1639 and by the Solemn League and Covenant of 1643, authorized by the Scottish and English Parliaments. Thus the origin of the term "Covenanter Presbyterian."

During this long period of conflict, a great many Scots settled in Northern Ireland, which was largely Protestant. Our ancestors apparently were among them.

The first great secession arose from an act of the Assembly in 1732, to do away with the right of the people to elect or choose their own ministers. The objectors then styled themselves <u>Associate</u> Presbyterians and seceded from the authority of the General Assembly. Further split offs followed.

The Associates divided within themselves into Burghers and Anti-Burghers, as a result of a dispute over the religious authority clause in the oath of office sworn to by the Burgesses of Edinburgh. The ministers had exercised authority in settling minor crimes among their members, and felt that the oath of office of the Burgesses appeared to deprive them of this power.

In 1820 about 300 of these Associate Churches united and formed The United Secession Church. By 1847 the total seceders numbered about 400. In that year they all merged and formed the United Presbyterian Church of Scotland.

Taking their cue from the Mother Country, the next ten years saw most of the Secession, Associate and Reformed Presbyterian congregations in America joining hands to form United Presbyterian Churches. It will be seen that there was little or no seceding done in this country. It had been going for over 100 years in Scotland.

Therefore the name "Seceders Corners" could properly be applied to any crossroads where there was located any Associate or Secession Covenanter Presbyterian Church. It simply meant that this congreation had seceded from the legally constituted Presbyterian Church of Scotland for one or more various reasons as explained above. The name of the Church would naturally be applied to the crossroads where it was located.

Early in the 17th century (1600's) the whole of the North of Ireland fell into the hands of the English and its former Roman Catholic occupants were dispossessed of their holdings. King James I repeopled the country with Protestant Scotch and English subjects who were given long land leases. In 1672 it was estimated that 100,000 Scots had their homes in the Province of Ulster alone. Nearly all were Presbyterian Covenanters.

About 1717-18 their long land leases began to run out. Rents were doubled and tripled. Religious reasons also were present. King James argued "no Bishop, no King" and threatened to "harry them out of the land."

An invitation from Governor Shute of Massachusetts resulted in the arrival in Boston, August 4, 1718, of five small ships bringing from Ulster about 750 Scotch emigrants. They settled in Londonderry, New Hampshire; Worcester, Massachusetts, and Colrain, and some in Rhode Island. This migration to the several seaports along our Atlantic Coast continued for the next twenty-five years. Baltimore and Philadelphia received their share of emigrants who settled at first in Virginia, Delaware and southeastern Pennsylvania, usually on farms.

THE FRANCIS HENRY FAMILY

OF

POLAND, CHIC

FRANCES LETAY I born est. 1750 1771. d. 1824. Probably buried in Old Prosbytorian Cematery, Foland, Ohio.

Wife, Agres (Carson?). Said to be one of two Carson sisters from Ireland and living in Delaware. The sister, Margaret, is thought to have married James Reed, a friend and neighbor of Francis Henry in Roland, Ohio.

Now, in 1957, it is nearly 200 years since the birth of Francis Henry, the first. Over the years, various descendants have left scraps of information, but no unified authenticated genealogy has been produced. Such a document to be authentic, should be based on facts from Court Records of Wills, Deeds and Marriages, Cemetery stones, Family Bible Records, and old family letters, memoirs or published books, all of which should be quoted. The supply of these factual records is, of course, limited. To fill in and round out the history, one must frequently rely on deduction and supposition. However, where this is done, it should be so stated, so that readers may know fact from legend or hearsay.

Readers should keep in mind that this history begins before the Revolutionary War, that Ohio was opened up to settlers about 1795 and did not come into Statehood until 1803. That this section around Youngstown was a part of the Western Reserve. A road by that name south of Youngstown marks one of the boundaries. The State of Connecticut sold this land about 1795 to several individuals who formed the Connecticut Land Company which in turn sold large parcels to individuals for about \$1.00 an acre. They in turn retailed smaller parcels to settlers over a period of about ten years, for from \$2.00 to \$5.00 an acre. Francis Henry settled near Poland, where he lived from some time after 1801 until his death in 1824.

There were two travel routes west for settlers. Those coming from New England and New York used the northern route along the southern shore of Lake Erie. Those from New Jersey, Maryland and Eastern Pennsylvania came overland to Fort Duquesne, now Pittsburgh, and Steubenville, then up the river by boat to Beaver Falls, then on north and west by foot, horseback, and wagon. Thus Coitsville, Struthers, Poland and Youngstown had settlers arrive on the southern route as early as 1798. Coitsville and Poland were a part of Trumbull County until 1846.

Keep in mind that conditions were very primitive. Land had to be cleared, log cabins built, transportation was by foot or horseback, limiting the number of social contacts to relatives, nearby neighbors and weekly church services.

Frequently one minister served two or three different churches rotating from one to another on different Sabbaths. There were also traveling or itinerant ministers who rode horseback, called circuit riders. Francis Henry's youngest son, John Henry, was one of these in later years. He was a Disciple minister, and was also the principal character in a novel by J. G. Riddle. He made his headquarters near Austintown, Ohio.

A circuit rider made long trips on a route that might take several months to cover. He administered to the spiritual needs of the settlers chiefly in performing marriage ceremonies, baptizing children, holding funeral services and conducting revival meetings. Many of them kept diaries in which they noted the names and dates of all services performed. Frequently, these diaries are the only existing records of very important events.

In cemeteries it was necessary to use the softer sand stones and ledge rocks available locally, because it was nearly impossible to get the hard granite from the East. Thus, the names and dates were soon worn down by the elements, until they were no longer legible. Shaley stones split off in layers, some fell down for lack of a good base and, of course, there has always been vandalism.

So it is understandable why the young people married at an early age; frequently married cousins; why two of one family often married two of a neighboring family; why authentic records are not always available. Fire destroyed many records.

Around the year 1390, it was the custom of many families, once a year to have reunions. A day was set aside in the full, when the harvesting was about complete. All the relatives, including little children would converge from far and near at the farm of one of the patriarchs. There would thus be present, several in their 70's and 80's, who really were early settlers themselves and knew from their life experience all the details of their family history and passed it on by word of mouth.

Someone has said that none of us are interested in our genealogy till we pass fifty years of age. However, in the 1890 period a great many families did appoint committees to compile a family history, while they still had the oldsters to consult for information that is vital.

Apparently, the Henry Family passed up that opportunity and so must now be content with a very restricted history for those who are interested.

There has been a legend in circulation that Francis I was in some way related to Patrick Henry of Revolutionary fame. Many early settlers from West Virginia did move into Washington County, Pennsylvania.

The genealogy of Patrick Henry shows the following:

Alexander Henry and wife, Jean Robertson, of Aberdeen, Scotland, had a son, John, who emigrated to Virginia prior to 1730. He married in 1733 a widow, Mrs. Sarah Winston (Syme) and lived in Hanover County. They had nine children, 2 sons and 7 daughters. The sons were William and Patrick, born 2-29-1735.

Patrick married in 1754, Sarah Shelton, and had six children. The males were named John, William and Edward. On 10-9-1777, he married for the second time Dorothea Danridge. Children of this marriage were born too late to include our ancestor. None of his children by either marriage were named Francis.

It is obvious that our Francis could only be related to this family in a collateral line beginning in Scotland, or through Patrick's older brother William. Children of Patrick's sisters probably would have married names other than Henry.

The first authentic information I find on Francis Henry I, appears in the deed to the farm he bought in Poland, Ohio, in 1301. Exhibit A. The deed states that he came from Washington County, Pennsylvania. This county lies just south and east of Allegheny County where Pittsburgh is located. It is on the main route west for all settlers from Virginia, Maryland, Delaware, New Jersey and eastern Pennsylvania. Originally it was a large county and generally considered to be a part of Virginia. Later surveys established that the southern sections be in Virginia (later West Virginia) while the northern part was placed in Pennsylvania.

We do not know how long he lived in Washington County. He apparently did not own land there for he does not appear on the tax lists. The names Francis Henry and Frank Henry appear but it has been demonstrated to my satisfaction by the Washington County Historical Society that neither one is our ancestor.

The next evidence appears in a book by A. S. Hayden, Exhibit F, giving the biography of Francis' youngest son, John Henry, who became a famous Disciple minister. The author states that John was the son of Francis, and was born in Chartiers Township, Washington County, Pennsylvania, October 1, 1797 and came to Poland, Ohio about 1303. The author says that he used great care and only cited facts after careful research. He and his father knew John Henry personally since before 1828.

His Will, written in 1322, Exhibit B, indicates that his son, Francis 2, was his eldest child. The tombstone of Francis 2, in the Hartzell Cemetery near North Benton, Ohio, gives the birth year as 1792. There is no evidence in Washington County, Pennsylvania, that any of the children, other than John, were born there. However, the last child, Betsey, who married Stephen Reed, was born in April of 1301 (from her tombstone). As he did not buy the Poland farm till October of 1301, Betsey was probably born in Washington County, Pennsylvania.

In the old cemetery at Poland, there is a large lot with one stone for his grandson, James Henry 3, but otherwise barren of stones. The probabilities are that this is the original Henry lot and the stones have been broken and lost. Hearby is the stone of his friend, neighbor and, possibly, brother-in-law, James Reed. Thus we have no cemetery record of his birth date.

However, if his children were born between 1792 and 1301, chances are he was married about 1790-1791. If he married at about the usual age, from 20 to 25, his birth year would fall between the years 1766 to 1771. This in turn, would make him too young to be eligible as a soldier in the Revolution.

The history of Francis I, prior to October 1797, is therefore, completely subject to conjecture, with very few clues to help. One clue is the deed to the Poland farm. He paid \$213.00 cash. This was a large sum in those days, the equivalent of several thousand dollars today. The only way a young man of about 30 years, with a family of a wife and six children could acquire that amount would be a wife's dowry or by inheritance. If the latter was the case, he was probably the eldest son, whose father (probably named Francis too) died about 1300 somewhere in the east.

A second clue comes from his wife's name, Agnes (Carson?). The legend, long circulated here, is that her last name was Carson, though no proof can be found. The James Reed family history, on later pages, mentions the probability that his wife's name was Carson. In 1329, shortly before James Reed's death, his wife's name was Mary, according to the Deed in Transcribed Deed Book #E, Page 142.

Mina Blott Russell 5, a lineal descendant of Francis Henry I, and married to Hugh Russell. a lineal descendant of James Reed I, recalls the legend that two Carson sisters, Agnes and Margaret, from Ireland and living in Delaware, married Francis Henry and James Reed. The Reed history states that one of James' sons, William, was boan August 22, 1778 (or 1793) at New Castle, Delaware, and that James enlisted in the Army at Chester, Pennsylvania, which is 40 or 50 miles farther up the Delaware River.

This would suggest that Francis Henry might have been raised in the general area of New Castle, Delaware, and Chester, Pennsylvania, in order to have met and married a Carson girl, according to the above legends.

I have consulted several books on Henry family genealogy. The most helpful was published in 1905 in Boston by Frederick Augustus Henry. He started out to look up his own family tree and in the process ran across a great many other Henry families. He collected so much fragmentary data on other than his own family that he decided to include them all in his book. Consequently, some thirty Henry families are discussed.

The only family that begins with a Francis Henry as the first emigrant reads as follows:

Francis Henry of Rhode Island, Warwick County, Kent who died September 14, 1765. Wife, Elizabeth. Died prior to 12-27-1765. His will uses the legal phrase "being in a weak and low condition" which is the same phrase used in the will of our Francis. However, history versed lawyers assure me that this repetition is not significant because it was used frequently by the profession in those days.

He left a house and form in Killingly, Windom County, Connecticut to his two sons, John and Robert.

John Henry 2, married Agnes _____ before 1772. On January 30, 1772, John, Agnes and Robert sold the farm.

Robert 2, married Elizabeth Anderson. Two children. Robert 2 died prior to 3-15-1795. Wife died in 1319. Her will mentions the two children, Margaret 3 and Francis 3 (born after 1752). Francis 3 had two children and was left the farm and one-half the house during his lifetime - at death, farm to go to his two sons, John 4 and Robert 4.

Francis 3, married Charity and died about 1342.
This is obviously not our Francis.

John 2 and wife, Agnes, who sold their interest in the farm in 1772, seem to have gotten lost by moving elsewhere. It is entirely possible they would have had a son and named him Francis. But where to look for them?

Another family with a Francis, is the following:

John Henry and wife, Elizabeth, bought land near Providence, R.I., on January 12, 1735. He died 12-4-1753 - 5 children. The oldest son, James 2, married Nancy (also called Anna and Hannah), had eight childrenthe youngest was <u>Francis</u>, est. birth 1757-1758. Received 12 shillings at death of James 2 in 1312. Obviously not our Francis.

The last one I shall mention, does not have a Francis, but the family fits in the picture geographically and the name Carson appears.

Robert and Mary Ann Henry, of Scotch descent, sailed from Coleraine, Ireland, with three adult sons, John 2, Robert 2, and James 2. In 1722 they landed in New Castle, Delaware. They located on a plantation in West Coln Township, Chester County, Pennsylvania. Both parents died 1725. James 2, married Mary Ann Davis and died 1734. Robert 2, married a sister, Sarah Davis, and moved to Virginia - eight children. Nothing more known. John 2, married Elizabeth DeVinne in 1723. He died in 1747 - eight children.

- I. William 3, b. 5-19-1729, married Ann Wood. He was prominent in the War. Lived near Lancaster, Pennsylvania.
- Postlewaite. V. Mary 3, married Bickham. VI. James 3, VII. Martha 3, married Carson. VIII. John b. 1743, married Elizabeth Russell of Lancaster, Pennsylvania, three children. Carlotte 4, Elizabeth 4 and William 4.

It might be rewarding to secure the detailed genealogy of this family, if such is available.

If it is correct that two Carson sisters married Francis Henry and James Reed, then all Henry and Reed descendants are very distantly related on the maternal side.

The birthplace of Francis I may yet be proven by the discovery of some old memoirs or letters. I suggest a search be made by all descendants.

In order to clear up the period prior to October, 1797, I have enlisted the services of a few of the experts in genealogical research work.

Mrs. W. A. H. McIlvaine, Assistant Curator - Secretary, Washington County Historical Society - Pennsylvania.

Mrs. C. F. Quillian - Counselor on the staff of the D.A.R., Washington, D. C.

Mrs. Guiles Flower, a former officer of the Pennsylvania Historical Society and for many years a professional in genealogical research.

Miss Nell Reeser, Professional Genealogist - York, Pa.

There were apparently two Francis Henrys in Washington County at about that period, as well as a Frank Henry, Joseph Henry, Robert Henry and a James Reed. The last four names appear on Pages 252 and 254 of the 1790 Federal Census, indicating they lived near each other, and were probably related. Townships are not shown. Francis does not appear in this census. Frank Henry could be the one who later on turns up in 1811 in Ohio near Austintown and has a son, John, who married James Reed's daughter, Nancy. These three Henrys were all married and had children in 1790.

The name, Francis Henry, does not appear until the 1793 original tax list of Cecil Township, on personal goods or live stock. This same Francis on June 10th, 1800 bought a small lot in Hopewell Township for 20 bushels of wheat. This he sold in 1809 for \$16.00. Wife's name, Nelly and/or Eleanor. Hopewell is at the other western end of the county in the wilderness.

No other evidences of property ownership, taxes or residence appear in the county records for a Francis. This Francis, as will be shown later, is the man whose military record has misled and confused some of the relatives for the past 50 years. Our Francis must have come into the county some time after the 1790 census and we know already that he left about 1802 or 1803.

Various inquiries have been made to Washington, D. C., as to the military record of Francis Henry, of Washington County, Pernsylvania. The above was a veteran and his record as it appears on his three pension applications from 1319 to 1320 has been supplied to:

J. S. DuShane, of the Sons of the American Revolution of New Castle, Pennsylvania in 1901. I have now discovered that he did this for the benefit of S. W. Smith, (a descendant of James Reed). Smith's daughter was Mrs. H. K. Gregory, while of a banker of New Castle, who wanted to join the D.A.R. but did not enter on the Francis Henry line.

Smith believed it to be our Francis and supplied the data to Mrs. Del Cain in 1905. I have Smith's letter to her.

The War Department and/or the Pennsylvania State Library supplied the same data to Mrs. J. C. Reebel of Ashtabula in 1921. To Mrs. Gaile Somers Bolotzer of Indianapolis, Inc., in 1926 and Grace E. Dade of Chicago, Illimois, in 1924.

It would appear that it doesn't pay to jump to conclusions. The data was all right but it referred to another man. One of the requirements of the Pension Act of March 18, 1318, was indigence. The Veteran had to take an oath that he was in need. Our Francis owned his farm in Poland, and lived there from 1303 till he died in May, 1324. The Veteran Francis lived in Washington County till he died in a fire the night of December 23, 1324. I have a copy of the news item December 25, 1824 from the Washington "Examiner." His wife's name was Elinor and Agnes. I have photostatic copies of his Pension applications and the court record of the administration of his estate. Register of Wills office - Washington County, File H-29-1825 - closed out 1831. Assets consisted of six month pension, total \$52.00. Legal representation other than Administrator, are listed as Joseph Kerr and Elizabeth (her mark X) Henry.

It has been suggested that a certain Sgt. John Henry, a Freeman of Topsfield, Mass., mentioned in some of the early New England histories, might be the ancestor of our Francis Henry the first. I have carefully investigated this possibility. Several of the later books that I have consulted state forthrightly that the name "Henry" is in error and should be "Hovey." The mistake must have been caused by careless hand writing of the original list or in the early copying of the list. Our genealogist, Mrs. E. J. Quilliam, personally searched all available Topsfield records in Topsfield and in Washington, D. C., and "found no one at all by the name of Henry. On the other hand, I found coveys of "Hoveys." She further states that there were 107 Henry families living in Pennsylvania at the time of the 1790 Census. Many of them trace back to Robert and Mary Henry who came to Chester, Pennsylvania, in 1722.

Our genealogist, Miss Nell Reeser, after carefully studying all the data collected, is of the opinion that our Francis I could be the son of the Francis Henry, pensioner, who died in the fire in 1824 in Washington, Pennsylvania. Proving it, she admits, would not be easy. On the other hand - if there was a relationship, it was not known to his friends and neighbors in Washington for I have seen the administration papers of his estate, where next of kin are mentioned as Joseph Kerr and Elizabeth Henry.

Genealogist, Mrs. F. S. McIlvaine of Washington County, Pennsylvania, concurs in the above possiblicity but frankly states the problem is beyond her.

The true answer will probably never be known. It fairness to the father and son theory, one must concede it to be possible, particularly if father and son were estranged over some family quarrel. Such things do happen in families.

In support of this fend possibility, please bear with the writer in a strictly personal observation. Having lived in this home field of the Henry family for considerably more than half a century and having now spent over a year in collecting all this data and meeting many Henry relatives for the first time, I have gradually formed a suspicion. That is, that there is a strain of independence running through the family, a tendency to be outspoken, possibly the word peppery would apply. To state it another way, the spirit of a closely knit family with loyalty one for another, is absent.

If this observation is accurate, and you readers will know, then it is not too difficult to go along with the possibility of a feud between the pensioner, Francis, and our Francis I and accept the theory that they were father and son.

The 1790 Census of Washington County, Pennsylvania, Page 254, lists a Frank Henery with a family of three males and two females under 16 years of age living near Canonsburg, Chartiers Township. The next township on the north is Cecil Township which abuts on Allegheny County, Pennsylvania.

In 1811, the Transcribed Deed Record, Book J, Page 566, records that Frank Henry bought from Turhand Kirtland and wife, Polly, 70 acres, Township 3, Range 3, in Austintown, adjoining land of James Reed. Names were often misspelled.

Frank and Francis andld possibly be cousins. James Reed also came from Washington County. Phebably one of Frank's sons (under 16 years in 1790) is the John Henry that married Nancy Reed, James' daughter, in 1822 and lived in Boardman.

The original tax lists compiled in 1955 by the Washington County, D.A.R. lists Francis Henry as being taxed in 1793 in Cecil Township, Washington County, Pennsylvania. This is the Francis who died in the fire December 23, 1824. Wife, Elinor.

"History of Trumbunt and Mahoning County" by E. Z. Williams and brother, published in Cleveland in 1882, Volume II, Page 59, states: "Francis Henry settled on the Yellow Creek below Poland in 1801 or 1802. Among his children were William, James, John and Francis. William settled in the township and remained for a short time. James removed to Austintown. Francis lived upon the old place until he was an aged man."

Page 62 - list of taxables in Poland for 1803 shows Francis Henry.

"Historical Collections of the Mahoning Valley" published 1876 by the Mahoning Valley Historical Society, Volume 1, Page 474, says, "In 1801 came Francis Henry and family."

"Memorial to Pioneer Women of the Western Reserve" printed in 1896.

The rugged conditions prevailing in the early days are described, Indians, etc. It also states "many of the early residents of Poland came from Washington County, Pennsylvania and were Presbyterians. The Sextons, Guthries, Henrys and Bucks."

The available information regarding Francis Henry I, is now reasonably complete. From his will we know that his wife's name was Agnes. Legend has it that her last name was Carson and that she outlived Francis, who died in 1824.

The present Nina Blott Russell is a fifth generation descendant of Francis Henry I, as follows:

Francis 1; Francis 2; John 3, married Sarah Forney; Jannie Henry 4 married Benjamin Franklin Blott; Min: Blott 5 married Hugh Russell of 710 Hillside Drive, Warren, Ohio. The latter is a descendant of James Reed through Thomas Reed, a brother of 3t phen Roed. See Reed family history in later pages. This is the second marriage of a Henry with a Reed.

Nina Russell is naturally pretty well verted in the history and legends of the two families. It is her understanting that two Carson sisters from North Ireland were living in Delaware. One named Agnes, married Francis Henry. The other named Margaret married James Reed. This agrees in part with Charles Summer Cock, author of the James Reed history, who says his ancestor is thought to have parried a Carson of Delaware." See the James Reed history on later p. 325.

Charles Cock states James Reed lived for a time near Harpers Ferry, Virginia, and that he emlisted in the Army at Chester, Pennsylvania, just across the river from Delaware.

At least one of James Reed's children, William, was born August 23, 1778, at New Castle, Delaware. He died at Deerfield, Ohio, 1863 according to the Reed history.

Through the Reeds, Mana Russell came into possession of a dinner plate and one half of a linen sheet, brought from Ireland by Margaret Carson, wife of Lomes Reed. Through her mother she obtained a square wash stand and a thest of drawers that belonged to Jane Sherer, wife of Francis Heary 2.

Lying in Poland or Youngstown being the south half of Lot number four in said Poland and contains according to the survey of said town, one hundred and three acres and sixty rous, be the same more or less. Bounds, west on the west line of said town hip; - south on lot number five; east on lot fourteen and north on remainder of said let number four.

To have and to hold the above granted and bargained premises with the appurtenances thereof, unto the seid Henry, his heirs end assigns, that at and until the ensealing of these presents. I am well seized of the premises as a good indefeasible estate in fee simple and have good right to bargain and sell the same in manner and form as is above written and that the same is free of all encumbrances whatsoever.

And furthermore, I the said Law by these presents bind myself and my heirs forever to warrant and defend the above granted and bargained premises to him the said Henry, to his heirs and assigns against all lawful claims and demands whatsoever.

In the name of God amen. Whereas I, Francis Henry of Poland,
Trumbull County and State of Ohio, being weak and in a low condition

I do leave and bequeath to my well beloved wife, Agnes, the one third of the profits arising from real estate, for her support for life, also one bed and bedding, one cow, four sheep and dresser affairs.

I leave and bequeath to My Son, Francis, all my real estate with all its appurtenances with one plow and horse gears - and I do hereby will that all my personal estate shall be sold and equally divided into five parts. That William Henry's son Francis Brown shall have one part - and James Henry's son Francis shall have another part, and Nancy Buck one other part, and John Henry my youngest son one other equal part, and my youngest daughter Betsy Reed the other part. In witness hereof I here unto set my hand this 13th February 1822.

EXHIBIT C

ESTIMATED BIRTIS OF CHILDREN OF FRANCIS HENRY I

The children are probably named in the will in the order of birth. Francis 2 is without doubt the eldest because he was willed the entire farm and given the father's name. This was the custom in the early days, being a carry over of the English system of primogeniture, to keep estates and titles intact.

The tombstone of Francis 2, buried in the Hartzell Cemetery, North Benton, gives his birth as 1792, death May 15, 1872 - 80 years. The birth month is not given.

The youngest child is Betsy who married Stephen Reed - December 16, 1819 by Turhand Kintland. I have seen the court record in Warren. She was born April 1, 1801, from tombstone in Deal Hill Cemetery. John was born October 1, 1797. Tombstone at Four Mile Run Cemetery.

The estimated births of the other three children must therefore be crowded in between 1792 and 1797.

The third child, James, married Polly Buck according to the court record in Warren, Ohio, February 12, 1811. If his youthful age at marriage was 17 years, his birth year would be 1794. Any later date would make him too young to marry.

The second child, William, would therefore have to be born between Frencis, 1792, and James, 1794, or 1793.

We have nothing to help with Nancy's age.

The fifth child, John, married Jane Kyle, January 10, 1322 by the court record in Warren. Eis birthday was October 1, 1797 - death June 1, 1844 from tombstone Four Mile Run Cemetery.

Know all men by these presents that we William Henry, James Henry, John Henry, James Buck and Nancy Buck, his wife, Stephen Reed and Betsey Reed, his wife, for divers good causes and considerations thereunto moving especially for one dollar and for the purpose of carrying into effect the last will and testament of our honored father. Francis Henry late of Poland in Trumbull County, deceased, received to our full satisfaction of Francis Henry of said Poland, have remised, released and forever quit claimed and do by these presents for us and our heirs justly and absolutely remise, release and forever quit claim unto the said Francis Henry to him, his heirs and assigns forever all such right and title as we the said remisors have or ought to have in or to a certain tract of land together with all the buildings and improvements appertaining to the same.

Situate in said Poland is bounded as follows viz. on the west by the west line of said Poland, south on lot no. five, east on lot no. fourteen, and north on the north half of said lot now owned by John Kidd and is supposed to contain about one hundred three acres and sixty rods being the same land that said Francis Henry, deceased, purchased of William Law and did by his last will and testament bequeath to his son, Francis Henry the above remised, but as we the heirs of said deceased have agreed not to record said will but settled the estate by mutual compromise, we now make this deed.

To have and to hold the aforesaid premises unto him the said Francis Henry to him and his heirs and assigns to the only use and behoof of the said Francis, his heirs and assigns forever so that neither we the said remisors, our heirs or assigns or any other person in our name and behalf shall or will hereafter claim or demand any right or title to the premises or any part thereof but they and every one of them shall by these presents be excluded and forever barred.

In witness whereof we have hereunto set our hands and seals the twenty sixth day of May in the year of our Lord 1824.

NOTE: The first four signers were sworn by John Carlton, Justice of Peace, Austintown Township May 26th, 1824.

The fifth signer, William Henry, was sworn by John Nisbet, Justice of Peace, Beaver County June 5, 1824 (probably Beaver Township, large town is North Lima)

Stephen Reed and Betsey Reed were sworn in Canfield, October 21, 1825 by Philo Chidester, Justice of Peace.

From these documents several facts may be deduced:

1. William 2, the second child, estimated date of birth 1793, was living on May 26, 1824 and probably a widower because a wife, if living, would have signed. It leaves unexplained the mention of a son of William's, Francis Brown, in the Will of Francis I - Exhibit B.

According to one of the old maps, J. A. Brown owned the farm adjoining on the north. One of the Brown girls may have been William's first wife, deceased prior to 1322, when the Will was written. The boy might have been called Francis Brown Henry to distinguish him from James Henry's son, Francis.

2. James Henry 2, the third child, estimated date of birth 1794, was living on May 26, 1824. His wife, Polly Buck, whom he married February 12, 1811 according to the Quarter Session record in Warren, Ohio, probably died prior to 1824. He is, therefore, a widower with a son, Francis Henry.

For reasons of his own, Francis Henry I, treated both widower sons alike in his Will. Instead of leaving them a share in his estate, he left their share to their children, his two grandsons.

- 3. It establishes the name of Nancy's husband as James Buck and the fact that both were alive May 26, 1324.
- 4. John Henry 2, date of birth October 1, 1797, is alive May 26, 1824.
- 5. Betsey Henry 2, date of birth, April 4, 1801, and her husband, Stephen Reed are both living October 21, 1825. The spelling of Betsey varies in different documents. This one places an (e) before the (y).
- 6. It accents the respect and affection of the children for their father. Its language "purpose of carrying into effect the last Will and Testament of our honored father" and again "we the heirs of said deceased have agreed not to record said Will, but settled the estate by mutual compromise."

It explains the footnote at the end of the Will "rejected by the Court but ordered to be recorded on motion of the executor." George Parsons, Clerk.

7. The signature of Francis' I widow, Agnes, does not appear on this last document, strongly implying that she died between the date of the Will, February 13, 1822, and the date of this document, May 25, 1324.

Deed from Francis Henry II and wife, Jane Sherer, to grandson Milton Henry. Dated February 24th, 1872. (He died three months later - May 15, 1872 - 80 years.)

NOTE: For reasons of their own, Francis II and wife, Jane Sherer, chose to make this transaction with their 26 year old grandson, Milton 4 - thus by-passing their son, William Henry 3 (Milton's father) who did not die until 1398.

Milton Henry 4 born 7-20-1346 and died 3-10-1930 - 34 years, married Anna Louise Cowden - born 10-26-1345 and died 1-24-1936 - 91 years. Had one son, Clyde, unmarried, born 7-17-1373 who has lived on the farm until this date, June 1956. In 1955 he sold the property for a building project and has now moved to a smaller home south of Petersburg, Ohio, on Route #90.

Milton Henry and wife, Anna, adopted, in 1894, Jane Davis, a daughter of John Davis and Martha Davis, the latter being Martha Wellington in 1896. Jane Davis Henry's married name is Emch.

Milton Henry died without a will. In the final settlement, Jane Emch shared in his estate. See Case No. 2773, Probate Court Journal Volume 32, Page 164 - also Will #20,521, Volume 37, Page 66.

Thus the final chapter is written for the Henry farm of Poland, Ohio. For 155 years it has been owned and occupied by some member of the family. Rather a unique record.

GENEALOGY OF FRANCIS HENRY I

AND WIFE (AGNES CARSON?)

Francis I and Agnes Henry bought a farm in 1801, on Yellow Creek, near Poland, Ohio. The first years were probably spent going back and forth from Washington County to Poland preparing the new place for permanent residence later on, for conditions here were pretty rough in the early days.

They had six children, Francis 2, William, James, Nancy, John and Betsy (as spelled in Francis I's Will). They were probably all born in Washington County, Pennsylvania.

The eldest child of Francis Henry I and Agnes Carson was Francis 2, born 1792, month and day not on tombstone, in Washington County, Pennsylvania, died May 16, 1872 and is buried in the Hartzell Cemetery, North Benton, Ohio. He served in the War of 1812 as a private in Captain Hines Company of Ohio Militia and drew a pension. He was given a veteran's land grant of 120 acres in Iowa which he transferred to his son, Harrison Henry, in 1855.

He inherited the original farm on Yellow Creek near Poland, Ohio after his father's death in 1024. He married Jane Sherer June 10, 1819. They lived on the original homestead until a few years before Francis' death, when they lived near North Benton with their children Richard Henry and Nancy Hartzell. Jane Sherer was born December 25, 1794 and died on May 23, 1835.

I have no information concerning her background. In the very old Westfield Cemetery near Bessemer and Mount Jackson, Pennsylvania, there are graves of the Sherer family. In the Poland Center Cemetery, which is one of the three oldest Covenanter churches in this district, I have found a Sherer lot. One very old brown stone reads simply "Nathaniel Sherer," the balance is illegible. Near it are some broken pieces of another old brown stone. Another reads "Jane, wife of John Sherer - died 1827 - age 56. (Therefore born 1771.) These are possibly relatives of the wife of Francis Henry 2. This church yard is but a mile or two from the Pennsylvania State line, and about three miles from the Henry farm in Poland, Ohio. Jane Sherer possibly lived just across the Pennsylvania State line. The 1850 Federal Census shows she was born in Pennsylvania, 1794, also Francis H II, 1792.

Helene H. Catherman, a granddaughter of Sarah Henry 3, a fifth generation descendant of Francis Henry as follows: Francis 1; Francis 2 married Jane Sherer; Sarah Jane Henry 3 married Joseph Clark Kennedy; Helen Kennedy 4 married J. W. Hull; Helene Hull 5 married C. Catherman.

Mrs. Catherman has a sampler made by Jane Sherer giving her birthdate as December 25, 1794. On the back is attached a conductivitien by her mother, Helen K. Hull, circa 1925, for a local exhibit of the fine handcraft of the olden days which reads "Jane Sherer born on the Sherer farm near Mount Jackson, Pennsylvania, born 12-25-1704. Died in her 90th year 1834."

William Henry 2, the second child of Francis I, born estimated 1793. Probably married the daughter of an adjoining farmer name J. A. Brown. Had one son, Francis Brown Henry. Lived in Poland Township a short time. He was living in Beaver Township (North Lima) on June 5, 1324, probably a widower. Nothing further known.

James Henry 2, the third child of Francis I, born estimated 1794. He married Polly Buck, daughter of William Buck, February 12, 1811 by John Blackburn (who was a vitness to the Will of Francis I). They had at least one son, Francis the Third. Lived near Austintown. He was living as late as May 26, 1824, probably a widower because Francis Henry I willed James' share of his estate, direct to James' son, Francis 3. This Francis 3, of the third generation, married his cousin, Mary Ann Henry 3, daughter of Francis Henry 2, and Jane Sherer. No issue. James Henry's wife, Polly Buck, it is assumed, died prior to 1322, the date of Francis I's will.

Nancy Henry 2, the fourth child, born estimated 1796, married James Buck, son of William Buck, about 1319. James Buck is buried in the Old Poland Cemetery. Stone shows birth year as 1794, died August 2, 1356. His Will states that his residence was Poland, Ohio. The Will mentions his youngest daughter, Eliza, by name and refers to several other children.

John Henry 2, the <u>fifth child</u>, born October 1, 1797, and died June 1, 1344. See Biography on following page.

Betsey Henry 2, the sixth child, born April 1, 1301 and died July 5, 1356. The data will be found following the John Henry section.

Adjoining are four more markers that appear to be some of their children.

Joshua Henry, died 11-23-1344, 19 years - 1 month.

Thomas, son of J. and J. Henry, died 3-19-1832, age 5 years.

Stephen, son of J. & J. Henry, died 3-28-1332, age 3 years.

Cornelius, son of J. & J. Henry, died 1-29-1345, age 10 years.

A few feet away on another lot is the grave of Joshua Kyle, Jane's father.

No more information on this branch of the Henry Family is available to me in this territory.

Fortunately, I have been able to contact a fifth generation descendant of Francis I, and fourth lineal descendant of John Henry 2, who is historically minded. I refer to Mr. Chester Henry, 1194 Christopher Street, Columbus 3, Ohio. He has done a tremendous amount of research on the Henry family in general and has compiled a complete family tree on the John Henry descendants. I shall here give the names and dates of the children of John Henry 2, as kindly supplied me by Chester Henry.

Other names and dates of later descendants will be found on following pages devoted to more recent generations.

John 2 and Jane Henry had nine children.

- I. Hanna Henry 3 born 5-23-1823, died 2-28-1886, married 2-23-1842 Beriah Ewing, born 4-2-1817, died 1-10-1901. Buried in Bluffton, Ohio. 10 children.
- II. Joshua Henry 3, born 12-16-1824, died 4-23-1844, buried in Austintown.
- III. Nancy Henry 3, born 11-4-1326, died 12-16-1887, married 3-24-1344 Dr. James Ewing, born 5-3-1323, died 10-18-1875.
- IV. Thomas Henry 3, born 11-1-1828, died 3-13-1832.

 - V. Stephen Henry 3, born 9-2-1830, died 3-28-1832. (See above)

Henry 4 born 10-15-1857, died 10-24-1916. John 4 married Martha Ann Shaw, born 9-17-1831, died 3-6-1897. Lived in Indiana. Parents of Chester Henry.

- VIII. Cyrus Henry 3, born 5-30-1837, died 9-23-1915, married 4-13-1872 Sarah Thompson, born 8-6-1850, died 4-7-1926.
 - IX. Mary Ann Henry 3, born 4-10-1842, died 4-19-1901, married John F. McCollum 1-12-1865.

Permit your historian now to digress for a moment.

There were two John Henrys, both from Poland and both married in 1322.

I have personally examined the records in The Warren Court House in that is called the Record of Quarter Sessions, and found the following:

John Henry of Poland married to Jane Kyle of Youngstown

January 10, 1322.

This agrees with the author of the biography of John Henry, Exhibit F. He and His father personally knew John Henry and state that he is the son of Francis Henry. He further states that Joshua Kyle was a leader of the Austintown Church in later years. However, he wrote about a great many individuals in his book, so some errors might creep in. There is one where he says John was notified of his wife's illness May 12, 1844 - went directly home - helped nurse her, then contracted typhoid fever himself and died in sixteen days - May 1, 1844.

The second entry is:

John Henry of Poland married Nancy Reed - May 30, 1322.

After reading the data on James Reed, on later pages, with all the personal details of his acquaintance with Francis Henry I, both came from Washington County, Pennsylvania, owning adjoining farms, about the same age, buried in adjoining lots, etc. One might be inclined to think that the Hayder book is in error.

However, in the Old Poland Cemetery on the lot between the Henry's and the Reed's, is a stone marked Nancy, wife of John Henry, died March 2, 1855, age 72 years, making her birth occur in 1783, some 14 years before 1797, the birth year of the John Henry, son of Francis Henry I. It is unlikely they would marry. We know that there were two John Henrys, possibly cousins, so Nancy Reed must have married the "other" John and author Hayden is correct.

To further prove this view, I quote the Will of Nancy Reed Henry dated March 1, 1353 and probated May 3, 1356 found in Volume 1, Page 591. "I, Nancy Henry of Boardman Township, do give and bequeath to my husband, John Henry, all my right and title in and to the real estate on which we now live, to be used and disposed of as he in his judgment shall think best".

Our John died in 1844 so this Nancy must be James Reed's daughter with whom he lived in Boardman in 1830. See the history of the James Reed family on later pages.

I am, therefore, considering it settled that our John Henry, son of Francis, married Jane Kyle.

1311 - Frank Henry bought from Turhand Kirtland and wife, Polly, 70 acres in Austintown - adjoining land of James Reed. Transcribed Deed Book J, Page 555 - Township 3, Range 3.

This could be the Frank Henery that appears in the 1790 census of Washington County near Canonsburg, Pennsylvania, having three males and two females under 16 years of age. If one son was named John, it could be the John Henry that married James Reed's daughter, Nancy, being neighbors in Austintown in 1811.

- 1343 John Henry to Lucy L. Parker Book L, Page 665, Township 2, Range 3, /ustintown.
- 1340 Same to Jacob Jones 16 acres Volume L, Page 666.

Betsey Henry 2, the sixth and youngest child of Francis
Henry I and wife, Agnes Carson, was born April 1, 1801 and died
July 6, 1356, age 55 years. She is buried in the Dean Hill
Cemetery, on the Palmyra Road about one and one-half miles northwest of Canfield, near the junction with Turner Road.

We have long known that she married Stephen Reed, from the marriage record dated December 16, 1819 by Turhand Kirtland in the Trumbull County Court House at Warren, Chio, and lived in Ellsworth Township near Canfield, Ohio. If James Reed and Francis Henry married two Carson sisters, according to legend, then, Stephen and Betsey were cousins.

Her stone reads "Betsey Reed, wife of Stephen Reed, died July 6, 1856 - age 55 years - three months - five days. Honored and affectionate wife and mother, Christian and philanthropist. May her memory be cherished through all coming time."

Her husband's stone is beside hers, reading "Stephen Reed, died October 13, 1370 - age 33 years - six months - seven days." He was, therefore, born April 5, 1795.

Next to them is a stone reading John H. Reed died Hay 4, 1871 - age 51 years - therefore, born 1820. This would be their oldest child.

Beyond this is a five foot monument with two names inscribed. One is John H. Reed, 12-17-1820 and died 5-4-1871. The second inscription reads: Charles T. Reed - born 12-17-1837 - died 12-3-1838.

It is obvious that both Johns refer to the same man, though not so clear why two stones were used.

On the other side of Betsey and Stephen is a stone marked "Hadacy, wife of Isaiah S. Reed - died June 19, 1371 - age 41 years." Therefore, born 1330. Isaiah Reed was another son who married Hadacy Dunlap.

Next beyond is a stone marked "Josiah Reed - died November 30, 1878, age 25 years - 3 months - 15 days". So born 8-15-1853.

Here then are the parents, Betsey and Stephen, with two sons, John and Charles T., and a grandson, Josiah Reed, and the wife of a fourth son, Isaiah Reed, married Hadacy (Dunlap) Reed, and the mother of Josiah Reed.

We are now indebted to Charles Summer Cock, a descendant of William Reed (a brother of Stephen) for the names of the eight children of Betsey and Stephen Reed. See the Reed section of this book. "Genealogy of the Family of James Reed, born 1755, died 1836" - compiled in 1927 by the above.

CHILDREN OF STEPHEN REED AND BETSEY HENRY:

- 1. Thomas, 2. John and 3. Charlie Reed were deaf mutes.
- 4. Jared Reed married Mattie Harris and lived in Niles, Ohio no children.
- 5. Isaiah Reed married Hadacy Dunlap 4 children.

Josiah Reed - died 11-30-1878 age 25
John Reed married Olive Burkey of Mineral Ridge 2 children
Elizabeth Reed married Thompson - no children
Frank Reed - single

- 6. Reed married Jane Hanson one son Walter Reed, an official with the U. S. Steel Corporation.
- 7. Amy Reed married James Eastman and lived Fort Wayne, Indiana.
- 3. Mary Reed, born June 13, 1335 married James Snyder of Akron two children Homer S. and Marren Snyder.

There are doubtless many descendants of this couple now living here abouts but at present they are not known to me.

I have seen the Court Record of the marriage of Stephen Reed to Betsey Henry on December 16, 1819 by Turhand Kirtland.

The transcribed Deed Records of Trumbull County transactions prior to 1346, now in Mahoning County Recorder's office, show that February 14, 1828, Stephen Reed bought 146.56 acres from J. Perkins in Ellsworth Township - part of section 25 - Range 4 cost \$359.50. Book K, Page 258.

Again, on August 27, 1833, he bought 27.86 acres adjoining, from J. A. Rockwell and wife, Mary, for \$100.00. Book K, Page 257.

These transactions indicate that Stephen Reed and wife lived in Ellsworth Township from 1323 until after August of 1333 at least.

The following Quit Claim Deed to Betsy Reed dated January 14, 1836 is interesting:

Quit Claim Deed

For \$5.00 received of Betsy Reed of Canfield Township, Trumbull County. Land in Township of Canfield in Number One of the Third Range of Township in Connecticut Western Reserve, part of Lot #15 in Third Division of lands in Canfield containing six acres.

Bounds east by Robert S. McClelland - south by McClelland and Henry Ritter, west by Joshua Reed north by highway known as Betsey Reed's third.

January 14, 1336

The description of the land deeded, mentions Canfield Township (not Ellsworth Township where Stephen's deeds are located in 1828 and 1833 for some 176 acres). In bounding this land in 1836, the thirteen signers for \$5.00 for six acres, state it is bounded on the north by highway known as Betsey Reed's third.

SHORT HISTORIES OF THE REED, BUCK & HARTZELL FAMILIES.

Readers have already noted that three of the children of Francis Henry I, married into the Reed and Buck families.

James Henry married Polly Buck, Nancy Henry married James Buck and Betsey Henry married Stephen Reed. Practically nothing is known concerning these two families yet they were friends and intimates of the Henry's. Likewise in the third generation, two children of Francis Henry II married into the Hartzell family, who were very respected pioneers that settled a little farther west near Deerfield and North Benton.

I have done quite a good deal of research on these three pioneer families and feel that readers will get a better idea about who they were and how much they contributed to the early days of the settling of Ohio, if their histories are inserted at this point.

After which we will continue with the record of the third generation of Henry descendants.

JAMES REED FAMILY HISTORY

Through Cal. H. Russell, a fifth generation descendant of James Reed, who now lives on the old Thomas Reed homestead near Austintown. Ohio, and his brother Hugh Russell (wife, Nina Blott, a Francis Henry I descendant) of Warren, Ohio, I was able to contact Mrs. J. B. (Marion) Duganne of S. Range Road near North Lima, Ohio. Her father was James Reed of the fifth generation. She has in her possession the following Reed History.

GENEALOGY OF THE FAMILY OF JAMES REED

Born 1756 - Died 1836

Compiled in June 1927 by Charles Summer Cock, a descendant of William Reed, brother of Stephen Reed, from notes gathered during the preceding twenty five years.

James Reed was a Revolutionary soldier and was probably born in County Antrim, Ireland in 1756. He died in Poland, Ohio, July 3, 1836 and is buried in the Old Poland Village Cemetery.

His first place of residence in America was probably in Delaware. He once lived at Harpers Ferry, Virginia, but enlisted in the War at Chester, Pennsylvania. After the War he settled in Poland, Ohio. He is thought to have married a Carson of Delaware.

His military record is available at the United States Pension Bureau, Washington, D. C. He applied for a pension September 3, 1832 at the age of 76 years.

There were eight children:

- James Reed 2, born 1794 and died March 14, 1378;
 M. Mary (Polly) Turner, born 1732 and died October 13, 1851.
 They had six children. They were Presbyterians and both are buried in the Canfield Village Cemetery, east of the town.
- Thomas Reed of Austintown, Ohio, married a Dutch girl, Hannah Gilbert. He died about 1863. Seven children. The Russells and probably Mrs. Fox, the Smiths and Mrs. Gregory of New Castle are descendants.

- 3. Stephen Reed was born April 5, 1795 and died October 13, 1378, married Betsey Henry, born April 1, 1301 and died July 5, 1356. They lived in Ellsworth Township and are buried in the Dean Hill Cemetery, northwest of Canfield, Ohio. They had eight children.
 - Thomas II, John III and Charlie Reed were deaf mutes.
 - IV. Jared Reed married Mattie Harris lived in Niles, Ohio. No children.
 - V. Isaiah Reed married Hadacy Dunlap buried in Dean Hill Cemetery and had four children.
 - a. Josiah born 1853 died 11-30-1878 Dean Hill Cemetery.
 - John married Olive Burkey Mineral Ridge - two children.
 - Elizabeth married Thompson no children.
 - d. Frank Reed single.
 - VI. Reed married Jane Turner a son, Walter, was an official of the U. S. Steel Company.
 - VII. Amy Reed married James Eastman lived in Fort Wayne, Indiana.
 - VIII. Mary Reed was born June 13, 1835 married James Snyder of Akron and had two children, Homer S. and Warren S.
 - 4. William Reed, born in New Castle, Delaware, August 23, 1778 or 1793, died at Deerfield in 1363. Moved to Portage County, Ohio in 1310, married Mary Middlesworth, born June 5, 1787 and died July 20, 1352. Her father was Anthony M. Middlesworth from Holland. They had thirteen children. See the original for complete list of names and dates. The author, Charles Summer Cock, descends from this branch.

- 5. Susan Reed married Robert Crossman four children and lived in Missouri.
- Nancy Reed married in 1820 John Henry (not a son of Francis).
- Elizabeth (Betsey) Reed married Henry Foster three sons and two daughters - lived in Wisconsin.
- 8. Margaret Reed married Solomon Gloss and lived in Lisbon and had no children.

It is unlikely that the above order of listing corresponds to the order of birth.

If it is a fact that Francis Henry and James Reed married Carson sisters, then all Henry and Reed descendants are distantly related on the maternal side.

The above is a complete list of second and third generations with parts of the fourth. Any lineal Reed descendants who are interested will have a good start toward bringing their own tree up to date.

THE JAMES REED FAMILY

OF

POLAND, OHIO

1756 - 1836

The earliest realty Deeds are Eleanor Reed et al to Turhand Kirtland in 1810 - 1812 - 1815. These are for land farther west of Poland and seem like an estate being settled.

In 1317, Alexander Reed from Cecil Township, Washington County, Pennsylvania bought from Moses Cleveland, Administrator, in Township 2, #1 Range, Lot #13. He and his wife, Martha, sold to David Reed, Sr. 220 acres. Book C, Page 453. In 1831, David Reed bought from Alexander Reed 228 acres and sold it in 1831 to Daniel Wick - Book F, Page 498.

There is a William Reed of Poland, died February 3, 1865. Will Book Vol. 2, Page 546 - leaving his farms to two sons, William and John. He seems a little too young to be the parent of Stephen Reed who married Betsy Henry on December 16, 1819 and Nancy Reed who married John Henry on May 30, 1822.

It is possible that the above Reeds are all related but the immediate family we are interested in, is the parent of Stephen Reed and Nancy Reed who married into the Henry family.

The following copy of a Deed first made between James Reed and wife, Mary, on August 29, 1329, and their daughter, Nancy Reed, wife of John Henry, later replaced by a deed dated September 7, 1330 in Book E, Page 345, is self-explanatory.

September 7, 1830 Deed Book E. Page 345

To all people to whom these presents shall come - Greeting,

Whereas, I, James Reed, late of Poland in the County of Trumbull and now of Boardman in said county did on the 15th day of March, last, for the purpose of relieving the property hereafter mentioned, from an incumbrance contained in a mortgage amount of Fifty Six dollars given Frances Henry and for the purpose of insuring a future support during my life, make, executive and deliver a deed to my daughter, Nancy Henry, wife of John Henry, designing to convey to her the land hereafter mentioned. The said John Henry having assumed to pay the said mortgage and having with his said wife signed a bond of Five Hundred Dollars conditioned to be operative if they did not support and maintain me during my natural life, but the said deed having expressed the consideration to be Three hundred dollars whereas the real consideration was as mentioned above and the said deed not having been executed according to law and void on that account and the said John Henry having paid and satisfied the said mortgage and having supported me from the date of said deed until the present time, - obligating himself to support me during my life.

Sells 15 acres adjoining Henry farm on South.

September 7, 1830

SIGNED: James Reed

The above shows that John Henry married Nancy Reed, daughter of James Reed. This John Henry is not the son of Francis Henry. See explanation of the two John Henrys on Page 26.

The mortgage transaction referred to is probably covered by Deed dated August 29, 1829 from James Reed and wife, Mary, to Francis Henry on 15 acres adjoining Henry farm. Transcribed Deed Book #E, Page 142.

I have not located any record of when James Reed acquired this property but it is unimportant. The facts are established that James was the father of Nancy Reed Henry; that his present wife's name was Mary; that his land adjoined Francis Henry; that they were friends and neighbors, possible both came from Washington County, Pennsylvania.

The wife, Mary, did not sign the second instrument implying that she died some time in 1830. There is a final piece of circumstantial evidence of their long friendship. In the Old Poland Presbyterian Church Cemetery adjoining the lot of the Henry's is a stone marked "James Reed, died 7-30-1836 - - 80 years of age. Revolutionary Soldier". He was therefore born in 1756.

The second deed states that James was "formerly of Poland, now of Boardman". It states that Nancy and John have been taking care of him, so he was probably living with them since his wife's death. I have not located any Will of James Reed. The above deed probably disposed of his only property.

I have in my possession a short pencil note written in 1905 from S. W. Smith of New Castle, Pennsylvania. I believe it was written to Del Caine. He speaks of her as cousin and states that he is enclosing the war record of her grandfather Henry (Francis H. II) who was in the War of 1812 and received a land grant in Iowa as a bonus, mentioned elsewhere. This land was later, May 3, 1855, transferred to her father, Harrison Henry. I have another note in my father's writing (Francis Henry Kennedy) stating that Mr. Smith's mother was a sister of Mrs. Fox whose maiden name was reed, and related. Mrs. Fox's father was a brother of Stephen Reed. The note says that at that time, 1905, Charles Russel lived on the Old Reed Homestead at Austintown. This apparently means the home of a brother of Stephen Reed. The brother referred to was probably Thomas Reed. A descendant, Cal. H. Russell and wife are living on the old homestead in 1956. now located on Route #46 about a mile south of Austintown.

He was born in County Antrim, Ireland in 1756, came from Ireland to Philadelphia in 1774, and then to Chester County, Pennsylvania, where he lived during and after the Revolution, until he moved to Trumbull County, Ohio. He entered the service in 1776, as a militia man from Chester County, Pennsylvania, serving two months under Captail William Armstrong and Colonel Montgomery. Later, in 1776, he joined the Flying Camp for five months under Captain Armstrong and Colonel Bull. About two weeks before the expiration of his enlistment, he volunteered from Fort Lee, to go with others to re-enforce the garrison at Fort Washington. They arrived on Thursday evening. On Saturday, the Fort was taken, and he was made a prisoner, taken to New York and detained thirteen weeks and three days, part of which time he was confined on the prison ship. He was then discharged on parole. He immediately enlisted for three years under Lieutenant John Steele, Captain Sample, Colonel Hoobly (or Hubly) 10th Pa. Regiment, under General Wayne.

He was in the Battle of Brandywine. The Division was later ordered to follow the rear guard of Cornwallis' Army, and when at a place called Paoli, Pennsylvania, the Americans were surprised and put to the bayonet. He was left for dead, with numerous bayonet wounds. He was found and taken to the "Sign of the Ship" on the Lancaster Road and continued ill. He was not able to rejoin the Army, and did not receive a regular discharge.

He died July 3rd, 1836, leaving a Widow. (widow's name not given).

THE WILLIAM BUCK FAMILY

1762 - - 1855

OF

POLAND, OHIO

Jame Buck and Wife, Nancy Henry, daughter of Francis and Agnes Henry
Polly Buck and Husband, James Henry, son of Francis and Agnes Henry

In the center of the old Presbyterian Cemetery in Poland, Ohio, stands the tombstone of "William Buck, died April 7, 1855 - age 93 years", therefore born in 1762.

On one side is a stone marked "Mary - wife of William Buck, died January 3, 1821 - age 50 years", therefore born 1771.

On the other side of William is a larger stone marked "Our Mother". The balance is illegible.

Next beyond Mother Buck is a stone marked "James Buck, died August 2. 1356 - age 62 years", therefore born 1794. Probably a son of William and Mary. Directly behind the stones of William and Mother, is a small marker upon which appear only the initials "N.B." I would judge this to be a child, probably a sister of William.

The transcribed Deed Book A - Page 96, of early Trumbull County records found in the Mahoning County Recorder's office, shows that in 1303, William Buck of Poland, Ohio, bought from William Law, of Connecticut, 265 acres in Poland. Further in Book B, Page 143, William Buck bought from the same party, 200 acres in Poland.

The first farm was bought just two years after Francis Henry, in 1801, bought 103 acres in Poland from William Law. Possibly Henry and Buck were old friends. Possibly both came from Washington County, Pennsylvania. These two transactions were among the very earliest of the settlers. Ohio became a State in 1803.

I have found no Will in Mahoning County for William Buck, and no mention of a wife in any deeds. Simply, the cemetery stone of Mary who died in 1821. It would seem that he remained a widower. No further realty deals until 1331-1832-1332-1335 and 1838 - three purchases and two sales - all in Milton, Berlin, Jackson and Austintown. I found no record of disposing of the two large original farms in Poland. No mention of his children.

In the 1830's there are 12 realty transactions. David Buck - 3 - to and from others: Jonathan-2, - to and from others; John - total 4 transactions and one to Samuel Davidson - 3 from others. In 1819, <u>James Buck</u> bought 53 acres in Austintown; 1831 bought 12 1/2 acres adjoining; 1833 <u>James</u> and wife, <u>Nancy</u>, sold the above 70 acres to Hays Brooks for \$990.00. In the same year, <u>James</u> bought 104 acres in Poland from Isaac Powers for \$1200. where the school house was located on the south half of lot #1. Book K, Page 105.

If William is the first and only Buck to buy land when Ohio became a state in 1303 it is reasonable to assume that the others are his children. James is probably the eldest because he bought land in 1319 from Noadiah Hooker and wife, Rebecca, in Austintown. The legend has long existed among the Henry family descendants, that Nancy Henry, second generation, married a Buck. The James Buck and wife, Mancy, sale, mentioned above, is the only clue as to which Buck she married. I am going to assume therefore that it is the case. Nancy Henry born estimated date, 1796, married about 1318 or 1819, James Buck, born 1794 and died 1356, son of William Buck of Poland, Ohio.

To greatly substantiate this surmise, I here quote from Will Book record in Youngstown, Ohio, Volume I, Page 589 - Will of James Buck dated April 7, 1856 and probated April 16, 1856, one week later.

WILL OF JAMES BUCK OF POLAND TOWNSHIP, OHIO:

- 1. "I give -- to my wife, Nancy, one third of all my estate both real and personal and also \$300.00 in money over and above the said third of all my estate.
- To my youngest daughter, Eliza, \$100.00 over and above her share of my estate hereinafter mentioned.
- 3. I give and bequeath the residue of my estate to all of my children to be equally divided between them"

This shows they had several children, one being Eliza Buck.

A difficulty now arises in attempting a surmise concerning the five transactions of a William Buck previously referred to above. In 1831-1832-1832-1835-1838. Was this party William Buck, Sr. or a son, William, Jr.? No mention is made in the two sales of a wife. A young man might be expected to have a wife, who would have signed the deeds. In as much as they took place approximately 20 years before William's death in 1855, it is reasonable to assume that he could have been still quite active. I am, therefore, considering them as transactions made by the father.

William Buck's other children, in order based on dates of land purchases, are estimated as follows:

Second child, John Buck; third, Jonathan Buck; fourth, David Buck.

In Warren, I have seen the record of a fifth child, <u>Polly Buck</u>, <u>married</u> February 12, 1311 by John Blackburn to <u>James Henry</u>, estimated birth 1794. They had at least <u>one son</u>, <u>Francis Henry III</u>. See Exhibit B. This son in the third generation is probably the one that legend says married his cousin, Mary Henry (daughter of Francis Henry II and Jane Sherer.) No issue from this marriage.

Webster's Dictionary states that "Polly" is the diminutive, often used instead of Mary. William Buck's wife was named Mary, and his daughter was probably baptized Mary.

I have no other information on the descendants of the two Buck-Henry inter-marriages.

THE ABRAHAM HARTZELL FAMILY

OF NORTH BENTON, OHIO

Abraham Hartzell of near North Benton, Ohio, married Sarah Smith on September 12, 1812. He was one of a numerous family of that name, all early settlers in that district. He was probably born about 1790. It is said he settled in Ohio about 1805.

His wife, Sarah Smith, was a daughter of Judge Smith who founded North Benton and for whom Smith Township was named.

They had six children in the following order of birth: James Hartzell, Nancy Hartzell, Simeon Hartzell 2, Caroline Hartzell 2, Sarah Ann Hartzell and Joseph Hartzell.

The fourth child, Caroline, was born June 20, 1823 and died July 6, 1910 at the age of 37. She outlived all her brothers and sisters. Many of the family are buried near North Benton in what is known as the Eartzell Cemetery.

From the notes of the minister's remarks at her funeral service, she was much beloved and deeply religious woman in the community.

On October 3th, 1845, her older brother, Simeon Hartzell 2, married Nancy Henry 3, of Poland, Ohio. They had four children and lived near North Benton - Chauncey, Frank, Ella and Clark Hartzell 4.

In October of 1851, Caroline Hartzell 2 married Richard Sherer Henry 3 of Poland, Ohio, a brother of Mancy Henry 3. Thus a Hartzell brother and sister married a Henry sister and brother.

Caroline and Richard S. Henry lived near North Benton and had seven children. Because their name is Henry and this is a Henry family history which begins one generation earlier than the Hartzell name, I will number them as the fourth generation of known Henrys. The children were Minerva Henry 4, Clara 4, George A. 4, Joseph Hartzell Henry 4, John Irvine Henry 4, Sallie Hanna Henry 4, Orrin Francis Henry 4.

Orrin Henry's 4 son, Raymond Henry 5, and wife, Cherie Ryerson, still live on the family farm as does their sister, Dora Dale Henry 5.

Credit must be given here to Mrs. Roth Malmesbury Ailes 5, and Mrs. Raymond Henry for their splendid work in gathering the above data from family Bibles, papers (which I have examined), relatives and tombstones in the Hartzell Cemetery which is nearby.

"Ephriam B. Hubbard was born in Duchess County, New York on February 23, 1792. His father, of Connecticut ancestry, moved to Deerfield, Portage County in 1802. July 1, 1817, he married Mary McGowan whose father came from Maryland. She had eight children and died October 13, 1839. Hubbard remarried Jerusha Reed."

"The Methodists pre-empted Deerfield. Ephriam Hubbard protested their creed. In Smith Township, a Methodist class was formed under the leadership of Sideon Hoadley, also Samuel McGowan, a Baptist, and wife a Presbyterian."

and long identified with it. He was born October 19, 1803 in North Hampton County, Pennsylvania. In 1805 his parents settled, with several other families of the same name and hindred in Deerfield, then quite an unbroken wilderness." He writes seven pages (313-320) that are quoted in the book.

Following are two excerpts. "On the second day of June 1825 the marriage contract between myself and Miss Alice Wallahan was consumated. My wife being a Methodist, we occasionally attended Methodist preaching. This brought before me the complications of Calvinism and Arminianism. The different parties acknowledge each other to be Christians, but each party says, my way is the right way" - and I, cannot tell which is the right one."

On infant baptism he says further on "My dear wife, I can give you no Bible evidence for infant baptism, for there is none. I am now convinced that it is a human device; and neither we, nor so much as one of our extensive family are in the Church of Christ, according to the law of the Lord."

This letter, quoted in full by the author, continues for about six pages, citing the various reasons, pro and con, on various religious beliefs. Perhaps some of the descendants would like to make a complete copy. The book is available at the Youngstown Library.

Having been raised in the wilderness, with apparently no opportunity for formal education, one marvels at his delightful literary style and vocabulary. The calmness and sanity of this discourse, all together, mark Jonas Hartzell as a scholar and a fine well adjusted gentleman.

THE WARTZELL FAMILY

OLD DEEDS

I have personally examined a great many of the old Deeds of Trumbull County under this heading in the index. There are at least two dozen, too many to attempt to list or describe. If any of the descendents wish to investigate more in detail, I can give them the reference book numbers and pages, and show them how to do it.

The Hartzells were very early settlers but located quite a bit west of Poland, prefty much where they are now.

The oldest deed is dated 1321 - direct from the United States Government and signed by President James Monroe. The name is spelled Jacob Hartzal. Located in West half of N.W. section #10, Township 18 -Range 5, dated October 2, 1321 - 79.0 acres.

Next, to the same party - east half of North west quarter section #10 - Township 13 - Range 5 - 77.9 acres - signed James Monroe - dated May 11, 1324.

Next, " to Henry Hartzell from the United States Government - north east quarter section #2 - Township 18 - Range 5 - signed James Monroe - 762 acres. Contificate #25 dated May 6, 1324.

Next: Henry Hartzell, of Portage County Certificate #672 - North East quarter section #2 - Township 13 - Range 5 signed John Q. Adams - April 20, 1825 - 752 acres.

Next: Jonas Martzell of Portage County - east half of South West quarter section \$4, Township 18 - Range 5 - dated August 14, 1826 for 75.83 acres - signed J. Q. Adams.

Next: Jonas Fartzell of Columbiana - East half of South West quarter section #4 - Township #18 - Range 5 - 75.33 acres - signed John Q. Adams, dated March 6, 1027.

These parties are probably the ancestors of many of the present living Hartzells and there are at least six deeds signed by two United States Presidents, in your possession. Many of these were written on parchment.

Just a few of the older Hartzell deeds are:

- 1833 John H. Sr. to John H. Jr. of Deerfield Township Portage County 82.74 acres \$240.00.

William Hartzell was a Justice of the Peace giving the oath on one deed in 1838.

The Mahoning County Atlas for 1874 shows on the map that Simon Hartzell owned Lot #5 - 145 acres and Lot #23 - 83 acres - joining on the West with A. Strong, owner of Lot #22 - 88% acres.

A mile or so north, there is shown the Nancy Hartzell property. Lot #33 - 82% acres and 9.03 acres. This piece adjoins David Hartzell.

I found nothing in the old deeds or the Atlas for Richard Henry.

THE HENRY FAMILY DATES

For the sake of convenience for the readers of this book, it seems wise to gather together on a few sheets, a compilation of important dates for the first three or four generations of the Henry family and their connections.

Fortunately, I have been supplied with at least six sources of original hand written records all more than 100 years old. In addition, I have gathered many cemetery tombstone records as well as court house documents. In the few cases where nothing is known definitely an estimated date is entered and marked estimate. Sources follow:

Helene Hull Catherman 5, has a two volume, very small size, edition of the Bible, printed in Edenburg in 1802. It belonged to her (and my) grandmother, Sarah Jane Henry 3 Kennedy.

Ruby Reebel 5, has a yellowed two page record booklet which came from her grandparents, John Henry 3 and wife, Sarah Forney Henry.

Clyde Henry 5, is the last resident of the old original Henry farm purchased in 1801, in Poland, Ohio. He is the only child of Milton Henry 4, and wife, Anna L. Cowden. He has a large family Bible from which I copied certain dates. It was the property of his grandparents, William Henry 3 and wife, Margaret Adams. I have also seen the tombstone records in the Poland Cemetery.

Raymond Henry 5, of near North Benton, Ohio, is the son of Orrin Henry 4; Richard S. Henry 3; Francis Henry 2. The latter and wife, Jane, are buried there. He and his nearby relatives have old Bibles and personal papers which I have examined for dates, as well as the cemetery tombstones.

Dorothy Gibson Eppley 5, has a yellowed four page booklet of names and dates which belonged to her grandmother, Eliza Henry 3 Rice. It includes both the Henry and Rice data. The latter family dates are on the last page of this compilation.

The above are all lineal descendants of Francis Henry 2. He had, however, three brothers, William 2, James 2, and John 2 and two sisters, Nancy 2 and Betsey 2. These five are called collateral lines of relatives. Very little information is available on William and James. I have found the cemetery tombstones of Betsey and her husband, Stephen Reed, and a meager record of their children. Court records show James Henry 2 married Polly Buck and Nancy Henry 2 married James Buck.

The remaining brother of Francis 2 is John Henry 2, the famous circuit rider preacher and revivalist who lived near Austintown, Ohio. While his life was short, only 47 years, he was easily the most renowned of the family and deserves a large space in this book.

I consider it our great good fortune that I have been able to contact a lineal descendant of John Henry 2, who is intensely interested in the Henry family genealogy. For many years of constant effort, he has been assiduously gathering data on the descendants of John Henry 2 and has now graciously supplied me with an almost perfect history to help make this book a complete Henry family history. Allow me to again credit Mr. Chester Henry 5 of 1194 Christopher Street, Columbus 3, Ohio, a son of John Warren Henry 4; Joseph Henry 3; John Henry 2; Francis Henry 1.

THE PURPOSE AND SCOPE OF THIS BOOKLET

From the start, the principal purpose of this work was to clear up the early history of the Francis Henry family of Poland, Ohio. To learn as much about his antecedents as possible, before he came to Poland. Then, to collect all the data available concerning his children and grand-children and the part they played in the early history of Ohio. Such a compilation would cover the first four generations and possibly some of the fifth. This would equal about 100 years. Anything more than that would be useless for a number of reasons. So many collateral lines have now been established that they have completely lost touch with each other.

After 150 years, there are possibly a thousand descendants by this time. Any long list of births and deaths of completely unknown people would prove rather dry reading. It would probably never be consulted unless to prove in court, a line of descent to settle some valuable estate or buried treasure. We are unable to prove that our Francis Henry took part in the Revolutionary War. Finally, the day after its completion, it would be obsolete because of new births and deaths every week.

In the last fifty years complete modern records of births, deaths, marriages, probate court and cemetery stones, are all available to any one wishing to look them up. What is needed is a place to start from and that is where I feel this book will be useful to the few of any branch of the family who may be interested in looking up their own lineal background.

A copy of this booklet will be placed on the shelves of the Mahoning Valley Historical Society where it will be available as a reference for all future genealogy students of the many, many connections of the early Francis Henry family.

Those interested especially in the line from John Henry 2, will also find there a most complete history including the seventh and eighth generations compiled by Mr. Chester Henry.

Mary Eliza Henry was married to Richard Olney August 1, 1863, buried Poland. Was a Methodist. Lived Marathon, Iowa.

Clyde Henry said that he was born July 17, 1373 and an only child. His Aunt Lucy Henry married John Blackburn. After his death, she married 2nd Thomas Wanamaker. His Aunt Emma Henry married Charles Mathews. Attended Methodist Episcopal Church and is buried in Poland.

His father, Milton Henry, has lived on this original Henry farm since he was two years old (1343). Clyde was born there. The original house was across the road, near the present lake. About six months ago he sold the house and farm for development of homesites. It is now built up with new houses and he is moving next week to a 1 1/2 acre place on Route \$90 just south of Petersburg, Ohio.

His grand parents, William and Margaret, lived on this original Henry farm and are buried in Poland. The farm lies just north of Poland at the crest of the hill just as you start down the Poland-Struthers Road and on the left.

WILLIAM HENRY 3 - born June 11, 1820, died April 15, 1898, married 1845, Margaret Adams, born November 29, 1821, died December 3, 1999, four children.

He was postmaster at Pierpont, Ohio and is buried there. For this information I am indebted to two daughters, Carriebelle, better known as Birdie or Carrie Johnson, 82 years, and sister, Sadie McCullum, 83 years.

Their mother, Belinda McCreary, was born in the little town of Eastbrook, Pa. just across the Pennsylvania State Line, not far from New Castle, Pa. This couple, with some friends, settled in Eagle-ville, Ashtabula County, Ohio, near the State Line. After her husband's death, Belinda lived in Youngstown with her daughter, Adele Cain.

Belinda's brother Enoch, had a daughter Mary Hazel McCreary, usually known as Hazel. When the child was about six months old, the mother died. Hazel was then legally adopted by a New Castle banker named Foltz. Later on, Foltz "went bad" (no explanation) but he returned Hazel to her father who had remarried. The adoption action was not voided. The stepmother had other children of her own. Soon relatives and friends notified Belinda that the child was being abused and neglected. Belinda then brought Hazel to live with her and her daughter, Adele Cain in Youngstown, where she was raised to maturity. In their home she was sometimes known as Hazel Cain for convenience, but was never legally adopted.
